

NASA

Giffords holds seats on the House Science and Technology, House Armed Services and House Foreign Affairs committees, and has served as chairwoman of the House **Space and Aeronautics Subcommittee**.

She is married to Veteran astronaut, Mark Kelly, who is scheduled to command the final flight of the Space Shuttle Endeavour which is slated for operation on April 1. He is also a Former Navy Captain and it's the US Navy who is very aware of Planet X's potentialities and have even outlined a Safe Haven for Retired Navy personnel in the Arkansas-Missouri Ozarks.. No more passwords? Obama considers Internet ID for Americans in bid to boost web security

Obama is spearheading a plan to boost web security by issuing American computer users with an Internet ID.

He's put the U.S. Commerce Department in charge of the **Cyber-Security Initiative**. The Obama administration is drafting a paper called the National Strategy for Trusted Identities, which investigates ways that web users can protect their online identities.

But Commerce Secretary Gary Locke was quick to reassure people that it wasn't a guise for more big brother government.

"We are not talking about a national ID card,' he said at the Stanford Institute for Economic Policy Research. We are not talking about a government-controlled system. What we are talking about is enhancing online security and privacy and reducing and perhaps even eliminating the need to memorize a dozen passwords, through creation and use of more trusted digital identities. The Commerce Department is setting up a national program to work on the project."

Possible methods of creating a 'trusted identity' could include issuing a 'smart card' or digital certificates that would prove that online users are who they say they are. They could then be used to buy goods and carry out financial transactions on the Internet.

White House Cyber-security Coordinator Howard Schmidt says:

"The move does not mean that anonymity will be

compromised. I don't have to get a credential if I don't want to. There's no chance that 'a centralized database will emerge. We need the private sector to lead the implementation of this.'

The decision to put the Commerce Secretary in charge of the issue has reportedly left noses out of joint at the National Security Agency and the Department of Homeland Security.

But it is likely to please privacy and civil liberties groups that have raised concerns over the dual roles of police and intelligence agencies.

Congress, Legislation, & the Law

Blowback for Obama in his Gulf oil spill inquiry as report suggests U.S. government should share responsibility

For months, Obama singled out British Petroleum for blame over the Gulf of Mexico disaster.



But a report from his own presidential commission claimed the US government should share responsibility for the environmental catastrophe.

Calling for wide-ranging reforms of the entire oil industry, the White House panel said regulators failed to keep up with the pace of technological advances in offshore drilling. The commission's co-chairman Bob Graham says:

"It is our government's responsibility that exploration and extraction occur in ways that are beneficial to the country."

BP didn't escape censure in the report, which said the rig explosion that killed eleven workers and caused the three-month oil leak was both 'preventable' and 'foreseeable.'

But while Obama repeatedly pointed a finger at BP alone at the height of the crisis, the commission said Transocean, the owners of the rig, and Halliburton, which installed a cement casing for the well, were all partly to blame for sacrificing safety for bigger profits.

The 48-page report still makes uncomfortable reading for the British oil giant, but it allays fears that the Americans would seek to make BP the sole scapegoat and reflects the findings of the company's own probe into the disaster.

When preliminary details of the investigation were leaked, BP's shares rose above 500 pence for the first time since the leak sliced the firm's market value in half last summer.

Analysts also said the findings make it much less likely that BP will be found guilty of gross negligence, which could save the company billions in additional fines.

The Obama administration launched civil suits against BP and four other companies involved in the leak last month, claiming they broke environmental laws. A criminal probe into the disaster is continuing.

The commission was created last May to look into the causes of the worst offshore oil spill in US history.

The seven-member commission said the government was too passive and that regulators were outmatched, underfunded and had conflicting responsibilities that interfered with effective oversight.

"Like it or not, oil and gas companies are in this together, and they must adopt rigorous standards through an industry-wide safety institute, or risk losing access to these leases and resulting profits."

Although the commission lacks the authority to establish drilling policies or punish companies, its findings could influence future court proceedings and legislative efforts.

It recommends that 80% of any fines paid by the oil companies should be used to help clean up the Gulf. The House Natural Resources Committee and the Senate Energy and Natural Resources Committee are both holding hearings on the commission's report later this month.

Big Pharma's Immunity in Vaccine Court

The Vaccine Liability Fund was created as an alternative to taking vaccine injury claims to court and provides a shield from prosecution for drug manufacturers. If someone sues for vaccine injury,

their case will not be heard in a normal courtroom, but in a special kangaroo court called the Vaccine Liability Court. Consumers finance both the Vaccine Liability Fund and the Vaccine Court. The special vaccine fund and court are based in tort law (a tort is a civil wrong) and this violates Constitutional due process.

To apply for damages as a result of vaccines, you must first submit to the "fund". Your case will then be handed over to the Vaccine Liability Court which consists of a panel of 3 to 5 selected individuals called 'Special Masters'. The Special Masters may or may not lack a medical background and may or may not lack knowledge of Constitutional due process laws. This is the panel that will "hear" your case to decide whether it has any merit. There is no jury. If your case is determined to have merit, you can receive compensation. If the Special Masters rule against you or you are not satisfied with their decision, you then have the option of filing your case with a federal or state court. You will likely be financially ruined by this time. It is rare for federal and state courts to even agree to hear vaccine cases and rarer still for them to rule against Vaccine Court.

A Special Master is appointed by a judge to make sure that judicial orders are followed and is an "adjunct to a federal court". Federal Rules of Procedure allow a federal judge to appoint a Special Master, with the consent of the parties, to conduct proceedings and report to the court. These appointed Special Masters can be attorneys, but that is not a requirement.

A common misconception is that vaccine liability funds are supplied by the manufacturers, yet I

discovered that they are financed by the consumers with a \$0.75 to \$3.75 surcharge per dose applied as an excise tax. The manufacturers deposit this surcharge fee to the vaccine fund and deduct it as an expense from their taxes.
