

Most of the state of Colorado is infected. Portions of Wyoming and Nebraska are also infected. The heaviest concentration of the disease has been found in game management Unit 9 north of Ft. Collins between US highway 287 and I-25 up to the Wyoming state line. Units around the Red Feathers area, Masonville, Glacier View, and Estes Park Colorado are also experiencing high levels of TRANSMISSIBLE SPONGIFORM ENCEPHALOPATHY.
